

for at-risk youth since 1998. We have expanded to add our Community Counseling Services program, offering prevention services for children, youth and families through Intensive In-Home Treatment. Each family is paired with a treatment team, consisting of a mental health therapist and a family behavior coach. This is a unique opportunity for families to be served in their community with a supportive and integrated team approach. Our treatment teams serve families with children and youth ages 2-18 who are struggling with serious emotional challenges. They develop treatment plans, in conjunction with the family and other professionals, that are developmentally appropriate and individualized for the needs of the family. The team works within the community, including consultation with the child or youth's school, when appropriate.

The goal of the treatment team is to assist the family with stabilization, regulation, parenting skills, conflict resolution and more; in order to help families develop tools to become successful, thereby preventing out-of-home placement.

**Treatment Model:** We use Dr. Bruce Perry's Neurosequential Model of Therapeutics as our trauma-informed approach. We use a variety of therapeutic techniques, such as CBT, Motivational Interviewing, Play Therapy, TFCBT, etc.

**Program Overview:** Family Tree works alongside people affected by child abuse, domestic violence and homelessness throughout their journey to safety and economic independence, providing emergency residential services, case management and advocacy, therapeutic services, outreach support, housing search and placement, education and employment support, among many other services.

The Family Tree Community Family Resource Team (CRFT) provides in-home therapy for at-risk youth in order to prevent youth from out-of-home placement. The program also provides intensive individual and family therapy with case management services to support families with youth who are transitioning back into the home, after the youth has been in out-of-home placement.

Family Tree SafeCare® Colorado is a flexible, free in-home visiting program for families with at least one child in the home, five years of age or younger. The program offers three topics to choose from and each topic can last six to eight visits. Families can choose to participate in one or all of the topics. Family Tree SafeCare® works with families located within Adams and Jefferson counties. Parents and caregivers work side-by-side in the home with a Parent Support Provider to build upon the skills they already have. SafeCare® Colorado provides parents and caregivers with free items such as electrical outlet covers, door latches and a health manual developed by pediatricians.

# **Gateway Residential Services**

**Eligible Populations:** GRS provides a full continuum of care for youth and families where any number of issues are prominent, including: family issues, abuse and neglect, aggressive and assaultive behavior, AWOL, acute psychiatric disturbance, poor social skills, oppositional or defiant behavior, negative peer group affiliations, anti-social behaviors, and problematic treatment and placement history. The GRS program specializes in working with youth who have complex clinical issues.

### **Program Overview:**

### Strength-based programming

GRS believes that the most effective youth workers are strength-based, relationship-based, meet basic needs, and inspire optimism in clients. Our strength-based approach focuses on identification, creation, and reinforcement of a youth's individual, family, and community strengths and resources as we focus on what is RIGHT with youth, not just about what is wrong with them. Pre-intake interviews includes discussions of strengths and from the start of placement, multiple assessments are completed with youth and families to continue to identify strengths. Our strength-based approach is used in all aspects of the programming – from treatment planning for individuals and families to applying an intervention process that was designed to guide team members as they address problematic behaviors with youth in day-to-day life.

### The Three Pillars of Trauma-Informed Care

GRS bases our trauma-responsive programming on the Three Pillars of Trauma-Informed Care as we work to develop health and resilience in youth and their families. Relationships are the agents of change. The more healthy relationships a youth has, the more likely he is to heal from past trauma and thrive. Gateway Residential Services embraces the belief that in order to promote change, a relationship-driven program that effectively addresses the components of safety, connection, and coping is imperative to the successful transition of the client. We prioritize establishing a safe physical and emotional environment where safety measures are in place and provider responses are consistent, predictable, and respectful; creating an environment of safe, stable, and authentic relationships with caring adults and peers to support healing and healthy development; and supporting the youth in developing pro-social behavior (social skills, emotional regulation, communication, conflict resolution, and problem solving) by recognizing strengths and successes and acknowledging them in daily communication.

### **Team Decision Making**

Gateway Residential Services program utilizes the Multidisciplinary Team (MDT) as the foundation for decision making for every youth placed. MDT meetings are conducted every month for every youth. We have an exceptional attendance and participation rate. It has been designed in a very structured way that allows for the youth to present and be the initial facilitator of each meeting. In addition, treatment plan revision, program participation, and therapeutic updates will be discussed at that time. Decisions made for the youth's overall treatment process are made through the MDT process and each youth, professional, and family member must be prepared with requests for changes in overall goals or special requests at the time of the MDT. If changes or special requests are required during the month and cannot wait for the MDT meeting, then group emails are utilized. In the case that the parents do not have an email then the case manager is responsible for involving them in the process via telephone or written communication at their visitation time.

**Gateway Residential Services continued** 

**Education Services:** GRS partners with Delta County Joint School District 50J to provide educational opportunities for all youth served. On-site education is provided through Grand Mesa Choice Academy, which offers online classes and affective education on a daily basis. Youth who are credit-deficient will be able to work on credit recovery to get back on track toward graduation as they complete the self-paced classes. As youth progress in treatment they may be eligible to attend public school as the next step in preparing for their transition.

**Treatment Model:** The Clinical Department provides individual, group and family services designed and tailored around the individual needs of the client. The needs of the youth, as determined by the MDT, identify the frequency of individual and family therapy(s). The "prescription" of services is determined upon placement and adjusted as necessitated by the youth and the transition/discharge plan. We approach treatment in client-centered, strength-based programming, focusing on trauma responsive care and building protective factors and resilience. Each client's treatment is designed to identify and address risk factors of abusive behavior and protective strengths on which to build upon. Multiple staff members have been trained and certified in Trauma Informed Care, Trauma-Focused Cognitive Behavioral Therapy, Play Therapy, and EMDR. All staff members are trained in CPI, which provides a multitude of tools and skills to therapeutically address youth struggles and offer daily opportunities for growth for the youth served.

Gateway's belief system is based off of and incorporates many beliefs and theoretical perspectives. The most significant perspectives and/or curriculums used are the Reclaiming Model, Systems Theory, Trauma Informed Care, Trauma-Focused Cognitive Behavioral Therapy, Pathways for youth and family, Growing Beyond curriculum, Cognitive Behavioral Therapy for youth offenders, and Positive Behavioral Support System, which are all Evidence Based Practices. Our goal is to individualize each youth's treatment plan to encompass the services that will best meet the youth's need at the time of placement, with the goal being the most efficient transition to a lower level of care. The treatment team starts discussing the transition plan from the start of placement to prepare for that move as soon as the client is ready for a lower level of care or to transition home.

Individual therapy is conducted on a weekly basis (minimum) and family therapy is typically every other week (minimum). Psychotherapy group sessions are conducted by licensed providers four to six times a week, non-licensed professional staff four times per week, and direct care staff 2-4 times per week. Groups in the milieu focus on developing coping tools, self-regulation skills, pro-social skills, and independent life skills. All youth have the opportunity to practice and refine what they are learning in groups through the milieu.


**Program Overview:** Our Residential treatment is community-based QRTP, providing individual therapy, family therapy, and group therapy for all clients to address long-standing issues around trauma, abuse/neglect, reunification, criminal behavior, emotional diagnosis, and education recovery. Therapeutic services are provided by a Master's level mental health professional. Clients attend school on campus for credit recovery/attainment or GED program. Family integration is also a key focus of our residential program

Our Day Treatment facility school J Wilkins Opportunity School provides educational instruction paired with interventions and therapeutic supports for students. Students work to manage their emotional and behavioral needs in the school setting to return to their home schools, or complete their education through diploma or GED. J Wilkins provides educational services grades 3rd-12th for area schools and our QRTP program.

Our Child Placement Agency licenses, trains and provides ongoing supervision and monitoring support for foster home providers.

Our Community/Outpatient/School Programs program provides an array of services for the community, primary children, adolescents and their families. Services include individual and family therapy in the home, community, office or telehealth; Behavior Coaching; Parenting and Life Skills; Play Therapy; Family Time and Supervised Family Time; Truancy Services; Alternatives to expulsion school programming in Adams County Schools; School based therapy services in Adams County.


